Dear Dr. Sun Huh,

The title mentioned above has been evaluated for inclusion in Scopus by the Content Selection & Advisory Board (CSAB).

The review of this title is now complete and the CSAB has advised to not accept the title for Scopus inclusion at the present time. For your information, the reviewer comments are copied below:

*This mono-institutional journal from the Ewha Womans University College of Medicine in South Korea has been in print since 1978.*

*The stated aims unusually include intent "to contribute to improving and serving human society based on the Christian values of education, truth, goodness, and beauty", suggesting that it has a faith based element.*

*It has been in print since 1978, over which time it has secured some 250 citations. However, it is only publishing fewer than 30 items per annum from many different subject areas, with no cohesion or structure to the content.*

*Moreover, a number of articles are not sourced from South Korea, and the overall impression is given of a serious lack of coherence or focus in the editorial strategy.*

*Therefore, regrettably, I take the view that this journal would represent a reputational risk to SCOPUS in its present form,.*

*It is displaying no safeguards to the uncontrolled influx of articles which a SCOPUS listing often attracts.*

*This journal would benefit from a clear strategic focus on Editorial policy and South Korean content which could be judged to be consistent with its local institutional origins.*

*The widely varying subject content should be consistently presented in distinct subject areas around understandable themes.*

If in the future these comments are addressed, you may decide to submit a new application at any time after the following date: January 2027.

At that time, you will be required to upload a cover letter detailing how the above comments have been addressed.

A full review will be conducted upon resubmission and having addressed all the abovementioned concerns will therefore not guarantee acceptance.
